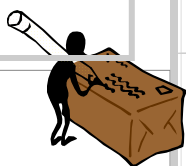

Our Victoria Chapter juries for Active status once a year in September, however, at any time during the year you can be juried through Vancouver FCA by sending 10 images either digitals or slides - no originals needed.

6. A 20% commission is charged on paintings sold.
7. **Unsold paintings must be picked up at the Gallery on Wednesday, October 13 between 5 and 6 p.m.**
